Canada will phase out fluorescent lighting by the end of the decade, starting with a ban on manufacturing and importing most fluorescent lamps by December 31, 2025. This initiative aims to reduce mercury pollution and promote the use of energy-efficient LED lighting, aligning with Canada's commitments under the Minamata Convention on Mercury.

Starting July 1, 2024, the International Credentials Recognition Act will simplify and speed up the process for internationally educated professionals to get their credentials recognized in B.C., removing barriers and making the process more transparent. The act impacts 29 professions and includes measures such as eliminating Canadian work experience requirements and ensuring fair fees for both international and domestic applicants.
